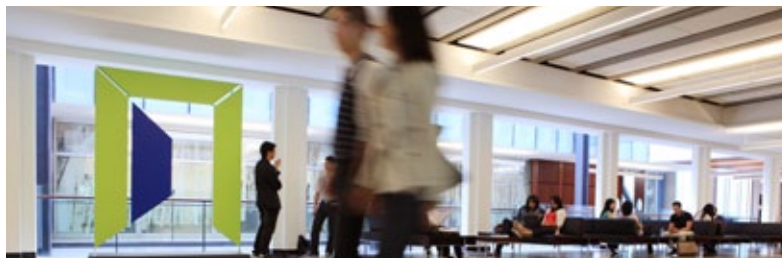
Sauder School of Business Facts

- ▶ In 2012, the Sauder School of Business was **ranked 20th in the world** for business school research by the Financial Times.
- ▶ Sauder is **one of the leading Canadian business schools in research funding** from major federal granting councils. In the 2010-2011 competition year, the school won 18 new Canadian government grants worth 1.65 million dollars.
- ▶ Sauder **graduates are employed at leading organizations and academic institutions around the world**. Recent graduates have been placed at Boston College, University of Chicago, UCLA, University of Michigan at Ann Arbor, Carnegie Mellon University, University of Toronto, Queen's University, University of Western Ontario, Hong Kong University of Science and Technology, Tsinghua University and Beijing University.
- ▶ A school with a distinctly **international perspective**, close to 60 per cent of Sauder's faculty are from countries outside of Canada with more than 30,000 alumni living in 70 countries around the world.
- ▶ For more than 30 years, Sauder's faculty has taught and conducted **research in China**, and established strong partnerships with leading Chinese universities, business organizations and government enterprises.
- ▶ In 2012, the Sauder School of Business and the Robert H. Lee Graduate School unveiled a **\$70 million renewal and expansion of its building complex on UBC's Vancouver campus**. The project, which provides a dedicated facility for the Robert H. Lee Graduate School, earned recognition as a winner of the Canadian Green Building Award.

Research Strengths & Facilities

With **15 specialized research centres** working with leading international companies, Sauder is bringing creative management practices to the marketplace. From the **Bureau of Intelligent Transportation Systems and Freight Security** and the **Centre of Operations Excellence**, to the **Centre for Health Care Management** and **ISIS**, an incubator for social innovation and sustainability, Sauder researchers are taking on business' most vital challenges and making an impact.

The **David Lam Library** at the Sauder School of Business provides access to an **extensive collection** of business research materials, including print and online books, journals and databases. **Significant online resources** include Standard & Poor's Compustat, Wharton Research Data Services, SDC Platinum, Bloomberg, Datastream, JSTOR, and collections by scholarly publishers, such as Wiley, Elsevier, Springer, and Oxford. Professional business librarians work with graduate students to identify and obtain information needed for research projects.
